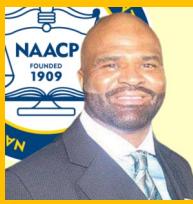

### EMMETT LOUIS TILL

July 25, 1941 -  
August 28, 1955

At 14 years of age, Emmett was lynched in Mississippi after being accused of offending a white woman in her family's grocery store.
